REQUIREMENTS & RESTRICTIONS

You must have a current insurance license. You're required to complete a short compliance training module. You must submit an Introduction using an approved form which acknowledges the client's permission for the banking partner to contact them (just fax it in). The lead must be accepted and qualified by the banking partner for them to purchase it. You do not have to be an expert in mortgage lending - the bank handles the entire transaction. The bank is not licensed in every state (but it is in yours). Your membership will be relinquished if you do not make introductions within a year (we've got to make room for those who do).
